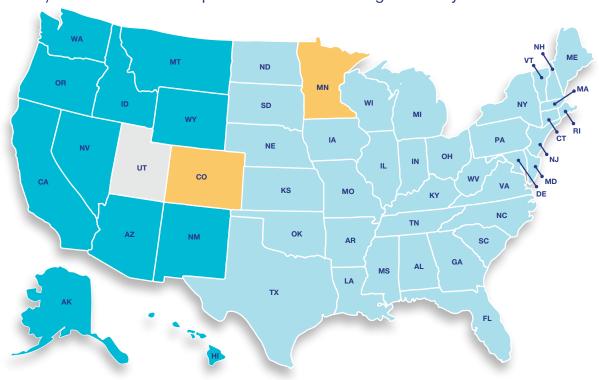
Prior authorization and other clinical letters are going paperless

UnitedHealthcare prior authorization and clinical decision letters are going digital. This means no more letters in the mail. Instead, network health care professionals (primary and ancillary) and facilities can view them online 24/7. Check out the map to see when this change affects you.



Western region - Effective date: April 1, 2022

Letters will continue to be mailed to: UnitedHealthcare® Medicare Advantage and commercial health plans in Colorado; UnitedHealthcare Community Plans in California, Arizona and Hawawii, Behavioral Health; Medicare supplement products; Sierra Health and Life; Rocky Mountain Health Plan; UnitedHealthcare West; UMR; UnitedHealthcare Global; Student Resources; Erickson Advantage Plans; and Home- and Community-Based Services.

Central, Southeast and Northeast regions – Effective date: June 17, 2022

Ways to view prior authorization and clinical decision letters online

Document Library - Document Library is a secure repository of claim-related communications and reports within the UnitedHealthcare Provider Portal. Go to Documents & Reporting > Document Library > Prior Auth Letters.

Notifications: When new letters are available, UnitedHealthcare sends an email notice to the address on file, which is typically the Primary Access Administrator. Health care professionals can also check Document Library at any time to see new letters.

Document Library notifications are limited to 1 email address per document type. If multiple staff members require notification, consider using a group email address. See our **Paperless Delivery Options for Primary Access Administrators** for more information.

Application Programming Interface (API) – Consider API if you have an automated intake of correspondence or significant prior authorization or clinical letter volume with UnitedHealthcare. API requires technical programming between your organization and UnitedHealthcare.
