Quarterly CPT[®] and HCPCS Code Updates

Beginning Apr. 1, 2023, all applicable Medical Policies, Medical Benefit Drug Policies, Coverage Determination Guidelines, and Utilization Review Guidelines will be updated to reflect the quarterly Current Procedural Terminology (CPT[®]) and Healthcare Common Procedure Coding System (HCPCS) code additions, revisions, and deletions.
