

# Diabetic Testing Supplies

## UnitedHealthcare Community Plan of Mississippi

UnitedHealthcare Community Plan of Mississippi uses the Mississippi Medicaid Single Preferred Drug List (PDL) for Fee for Service and Managed Care Organizations (MCOs).
