This memo is a revision of the previous memo regarding "stand-alone vaccine counseling" which refers to when a patient and/or caregiver receives counseling about a vaccine from a health care practitioner, but the patient does not actually receive the vaccine dose at the same time as the counseling. On June 8, 2022, the Centers for Medicare and Medicaid Services (CMS) issued new <u>COVID-19 stand-alone vaccine counseling</u> <u>specific HCPCS codes</u>. CMS requires states to cover stand-alone vaccine counseling for all vaccines covered under EPSDT, including both COVID-19 and non-COVID-19 vaccines. CMS also indicates that states have the option to cover stand-alone vaccine counseling for Medicaid beneficiaries who are not eligible for EPSDT.

Effective April 1, 2023, TennCare MCOs must cover stand-alone vaccine counseling for all vaccines for TennCare members and CoverKids members of all ages. TennCare providers should begin to use the codes provided in the tables attached to this memo when providing vaccine counseling. **These codes replace the TennCare guidance provided in the <u>TennCare memo</u> dated February 25, 2022, and these codes are to be used when providing stand-alone counseling for COVID-19 and non-COVID-19 vaccines whether provided in-person or provided via telehealth (including televisual or audio-only).**

TennCare recognizes the additional administrative responsibilities placed on Tennessee's providers when providing vaccine counseling. It is important that Tennessee's providers take time to answer any questions that Tennesseans may have concerning vaccines so that Tennesseans may receive this professional consultation and make a personal decision regarding the vaccine.

Reimbursement of stand-alone vaccine counseling for TennCare and CoverKids members of all ages will remain in effect on a permanent basis. TennCare's MCOs should notify providers as appropriate of this change by posting this update to your MCO's provider website and emailing a provider alert/bulletin/e-blast.
