## Quick Reference Guide

UnitedHealthcare Core is an open-access commercial member benefit plan that features a narrow, national network of care providers.



### Key Features

- Members have access to a national Core network of care providers.
- Members can choose any Core network physician or health care professional without a referral and without designating a primary care provider (PCP).
- Includes options for network-only or out-of-network benefits, depending on the plan model.
- Standard prior authorization and notification requirements apply.

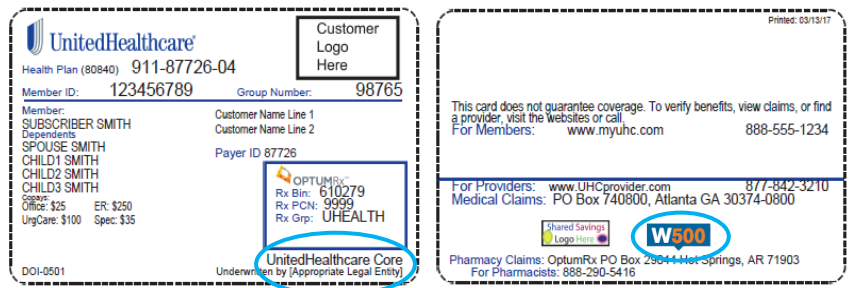
