Enrollment in UnitedHealthcare West EFT currently applies to payments from SignatureValue HMO and Medicare Advantage HMO plans only.* You'll continue to receive checks by mail until you complete your enrollment.

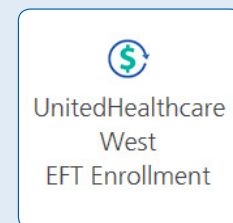
With the UnitedHealthcare West EFT Enrollment tool, you can:
