

# Z-Code requirements for molecular diagnostic testing

DEX Diagnostics Exchange

## Overview

As of **April 1, 2024**, you began registering tests that are in scope for the DEX Z-Codes® for certain molecular diagnostic test services on facility and professional claims. This is part of our updated **Molecular Pathology Reimbursement Policy, Professional and Facility**, which went into effect June 1, 2024.

DEX is a web-based registry that Palmetto GBA administrators use to provide unique identifiers for molecular diagnostic tests. This identifier helps provide transparency of the service for claims adjudication.

Tests **added going forward will** need to include the appropriate Z-Code on their claims to be considered for reimbursement. You can find more information at [dexzcodes.com](https://dexzcodes.com).

## Frequently asked questions

### Where do I go to register my tests in the DEX registry?

### How long does it take to receive a DEX Z-Code when registering a test with DEX?

Palmetto reviews laboratory information and test information within approximately 14 days of submission, resulting in a DEX Z-Code assignment.

### What happens after I receive an initial DEX Z-Code assignment?

After the initial Z-Code assignment, Palmetto reviews the documentation. If no additional documentation is required, you'll receive a notification of an assigned CPT® code for the test. This process takes approximately 30 days from Z-Code assignment.

More complex tests may require additional documentation and could take up to 60 days from Z-Code assignment for the CPT code to be assigned. Once both the Z-Code and CPT code have been assigned, you should submit claims with the Z-Code and assigned CPT code.

## **Once registered as a user, how do I add my tests to the registry?**

Select the Add Test action button from the Catalog Overview or My Diagnostics Exchange tabs within DEX. Complete all required fields and submit for review.

## **If we use a reference lab for a particular test, how do we register our DEX Z-Code identifier?**

Both labs must register in DEX. The performing lab submits the test details to receive the Z-Code. If you send your labs to a reference lab, you must request sharing in DEX to obtain access to the Z-Code. The billing lab uses the Z-Code of the performing lab. The 2 labs link in DEX with a sharing request. Labs may only request Z-Codes for tests performed in-house.

## **How do I register a test that's performed at 2 different locations in the DEX?**

Only 1 lab should apply for the test if it is a standardized process performed in both locations. However, if there is a difference in the method, an application will be required from both locations.

## **Is the Palmetto DEX Z-Code the same as the Genetic Test Registry (GTR) ID from the National Institutes of Health (NIH) GTR?**

No. The GTR ID is created when labs register tests with the NIH GTR. As part of this policy update, you're no longer required to submit the GTR ID on claims.

## **Do we need the DEX Z-Code identifier for reimbursement by UnitedHealthcare?**

Yes. When reporting molecular diagnostic tests you must submit a Palmetto DEX Z-Code identifier on the claim for the services to be considered for reimbursement. Using a Palmetto DEX Z-Code identifier on the claim should help reduce medical records requests and increase payment speed.

## **Where do I submit the DEX Z-Code identifier on the claim?**

Submit the Palmetto DEX Z-Code preceding the decimal in field 2400 SV-101-7 for professional lab services submitted on the electronic claim form or in the shaded area of the service line in box 19 on a paper claim form. Facility lab services should fill out line SV-202-7 for electronic claims or block 80 for paper claims.

## **Do we need a DEX Z-Code for all genetic tests or only those with 81479?**

## **Are labs reimbursed separately for multiple CPT codes for a single assay that may involve multiple tests that produce a single result?**

One CPT code and its associated DEX Z-Code are reimbursable for a single assay that may involve multiple tests for a single result. We'll deny duplicate or multiple molecular pathology CPT codes reported with the same DEX Z-Code for the same patient on the same date of service.

## **Can the test be retired from the DEX Z-Code registry if the lab no longer performs the test?**

Yes, in the event a test is retired, please update your DEX test submission with this change.
