#### Want timely payments?

Here are helpful tips to ensure you receive timely payments and avoid delays:

- Submit your claims through providers.eyesynergy.com.
  Electronic submissions help reduce claims errors, resulting in faster processing times.
- Sign up for free electronic funds transfer (EFT) and electronic remittance advices (ERAs) via PaySpan Health for help improving cashflow
- Verify member eligibility for the date of service, prior to rendering services at providers.eyesynergy.com
- Use our Provider Reference Guide for guidance and details on submitting clean claims

We understand that getting your payments as quickly as possible is critical to running your business successfully. Claims are paid 3 times per week (Monday, Wednesday and Friday) for providers in our vision networks.

# Reminder to verify member eligibility and benefits prior to rendering services

Always verify a member's eligibility and benefits prior to rendering services. Use the following verification steps to help prevent your claims from being denied:

- · Log in to your providers.eyesynergy.com account
- · Search for the member
- · View the member's benefit summary page

A confirmation can then be generated for eligible services. If services are provided to a member who is not eligible on the date of service, your claim will be denied.
