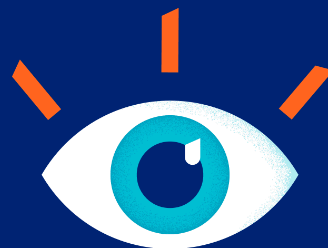

## Florida

### Important claim information regarding your address

Effective Sept. 1, the rendering and billing address(es) on your claims **must match exactly** what's on file with Florida Medicaid or your claims will be denied.

For example, if the address you include on your claim is 123 Main St., but the address you have on file with the state is 123 Main Street, your claim will be denied.

Please ensure both addresses are identical to avoid claim denials.
