California providers: Alameda Alliance membership update

Alameda Alliance is now the only Medi-Cal plan in Alameda County. Alameda County changed its Medi-Cal Managed Care model from a 2-plan model (Anthem and Alameda Alliance) to a single-plan model (Alameda), on Jan. 1, 2024. Alameda Alliance expects an increase of approximately 130,000 members due to this change.

Texas providers: New required training for providers.eyesynergy.com

Due to a regulatory requirement in Texas, all new providers must complete our **providers.eyesynergy.com training course** and attest before becoming a participating provider. As an existing provider, any new health care professionals that you plan to add to your group must complete this required training.

Texas providers: Routine eye examination billing reminder

Routine eye examination with refraction testing may be reimbursed using procedure codes S0620 and S0621. These codes are considered routine eye examinations and must be billed with diagnosis codes Z0100 or Z0101.

We'll deny procedure codes S0620 and S0621 if they're billed with

the same date of service as procedure codes 92020, 92265, 92270, 92273, 92274, 92285, 92286 and 92287.
