Calculating the ACV Achievement Bonus opportunity

You can earn an additional bonus when you achieve an Average Star Rating (ASR) of 4.25 or higher and complete ACVs for at least 70% of your patients who are MA-APCPi customers. We pay this bonus at the end of the program year.

Percentage of ACVs completed	Payment for ACV Achievement Bonus per member per year (PMPY)
90% and above	\$125 PMPY
80–89%	\$100 PMPY
70–79%	\$75 PMPY
Less than 70%	\$0

*We'll pay the CBP bonus annually based on the member's final CBP value of the year.

Example Q4 ACV Achievement Bonus and ACV superior bonus payment

In this example, the provider achieved an ASR of 4.40 and 79% ACV completion at year-end, earning the \$75 PMPY ACV Achievement Bonus.

Calculating the High Priority Comprehensive Care Bonus

Example Q4 High Priority Comprehensive Care Bonus

In this example, the ACO had 700 High Priority Customers who were 100% compliant in the High Priority Comprehensive Bonus as of the final PCOR of the year (April Runout 2026).

Average Star Rating Bonus incentive

ACO will be eligible to receive a year-end per member per year (PMPY) payment if they achieve an Average Star Rating (ASR) of 4.0 or greater across all eligible MA-APCPi Quality Care Measures.

4.50–4.74	\$125 PMPY
4.25–4.49	\$50 PMPY
4.00–4.24	\$25 PMPY

Average Star Rating Adjustment Bonus

ACO will be eligible to receive a positive adjustment to the Average Star Rating if the ACO meets or exceeds the performance target for any of the following Quality Care Measures.

Example Q4 MA-APCPi ASR

In this example, the ACO achieved a 4.20 ASR and .05 ASR Adjustment for hitting the MRP Performance Target. ACO earned an overall ASR of 4.25 and is eligible to receive \$50 PMPY.
