Calculating 2024 MCAIP payments

The Medical Condition Assessment Incentive Program (MCAIP) aligns with the Medicare Advantage Primary Care Physician Incentive (MA-PCPi) program. MCAIP offers 3 bonus opportunities when you assess suspect medical conditions for your patients.

This guide can help assist you in calculating your quarterly and annual Medical Condition Assessment Incentive Program (MCAIP) payments.

MCAIP Incentive Payment Summary

You can find information about your quarterly/annual incentive performance and payment on the MCAIP Summary and Suspect Detail worksheets, which are available in your Patient Care Opportunity Report (PCOR). To access your PCOR, sign in to the UnitedHealthcare Provider Portal and select **Documents & Reporting**, then **Physician Performance Based Compensation Program**.

Payment information

Your payment information will be available in your PCOR quarterly as follows:

- Q1: July 2024
- Q2: October 2024
- Q3: January Runout 2025
- Q4: April Runout 2025

The payments are based on your attributed membership at the time of payment.

MCAIP suspect assessment earning opportunities

To calculate your bonus earning opportunities, please reference the MCAIP Summary within your PCOR, as well as the following chart.

For each suspect assessment bonus you close for a member, we'll multiply it by the payment per activity.

Medical condition assessment superior bonus

You can earn the superior bonus if you achieve at least a 4.00 Average Star Rating in the MA-PCPi program and assess at least 65% of suspect conditions.

Percentage of suspect conditions assessed	Medical condition assessment superior bonus
95% and above	\$125 per member per year (PMPY) ⁴
85–94%	\$100 PMPY
80–84%	\$75 PMPY
75–79%	\$50 PMPY
65–74%	\$25 PMPY
64% and below	\$0 PMPY

Example of medical condition assessment superior bonus

If you achieve a 4.05 Average Star Rating in the MA-PCPi program and assess 78% of your eligible patients' suspect conditions by year's end, you can receive \$50 PMPY.

Medical condition assessment superior bonus

You can earn the superior bonus if you achieve at least 60 Performance Points in the MA-PCPi program and assess at least 65% of suspect conditions.

Percentage of suspect conditions assessed	Medical condition assessment superior bonus
95% and above	\$125 per member per year (PMPY) ⁴
85–94%	\$100 PMPY
80–84%	\$75 PMPY
75–79%	\$50 PMPY
65–74%	\$25 PMPY
64% and below	\$0 PMPY

Example

If you achieve 73 Performance Points in the MA-PCPi program and assess 78% of your eligible patients' suspect conditions by year's end, you can receive \$50 PMPY.
