# Application

This Medical Policy only applies to the state of Pennsylvania. Any requests for services that do not meet criteria set in the PARP will be evaluated on a case-by-case basis. Refer to <u>Pennsylvania Exceptions, Pennsylvania Code, Title 55, Chapter 1101</u>.

#### **Coverage Rationale**

Non-hybrid cochlear implantation is proven and medically necessary under certain circumstances for bilateral sensorineural and/or for single sided or asymmetric <u>Sensorineural Hearing Loss</u> in adults ages 18 and older. For medical necessity clinical coverage criteria, refer to the InterQual<sup>®</sup> CP: Procedures, Cochlear Implantation.

Non-hybrid cochlear implantation is proven and medically necessary under certain circumstances for bilateral Sensorineural Hearing Loss in children ages 9 months or older and for single-sided or asymmetric bilateral sensorineural hearing loss in children ages 5 years or older. For medical necessity clinical coverage criteria, refer to the InterQual<sup>®</sup> CP: Procedures, Cochlear Implantation (Pediatric).

Non-hybrid cochlear implantation for single-sided or asymmetric <u>Sensorineural Hearing Loss</u> in children younger than 5 years is experimental or investigational, due to lack of Food and Drug Administration (FDA) approval.

Hybrid cochlear implantation is proven and medically necessary under certain circumstances for <u>Sensorineural Hearing</u> Loss in adults ages 18 and older. For medical necessity clinical coverage criteria, refer to the InterQual<sup>®</sup> CP: Procedures, Cochlear Implantation.

#### Definitions

**Sensorineural Hearing Loss (SNHL)**: Occurs when there is damage to the inner ear (cochlea), or to the nerve pathways from the inner ear to the brain. Most of the time, SNHL cannot be medically or surgically corrected. This is the most common type of permanent hearing loss (American Speech-Language-Hearing Association [ASHA]. Sensorineural Hearing Loss).

Cochlear implants external components (i.e., speech processor, microphone, and transmitter coil) are considered under the DME benefit, and the implantable components are considered under the medical-surgical benefit.
