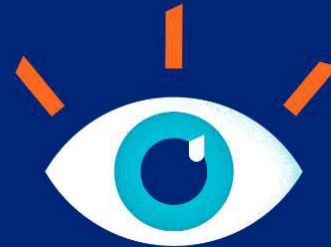

21st Century Cures Act implementation in Virginia

The 21st Century Cures Act claim evaluations begin on Sept. 1, 2023. We’ll match all rendering and billing provider information on claims against the Virginia Medicaid provider enrollment file. If the rendering and billing information is missing from the state enrollment file, claims will not be eligible for payment.
